## **DRIVER PARTICIPANT AGREEMENT, PERSONAL INJURY DISCLAIMER, LIABILITY RELEASE & EXPRESS ASSUMPTION OF RISK**

I, \_\_\_\_\_, hereby affirm that I have been advised and thoroughly informed of the risks and hazards inherent in high speed driving on open roads in wilderness areas, I knowingly and voluntarily assume such risks, including the risk of injury or death, and I hereby acknowledge and agree as follows:

### **General Stipulations:**

I am attending the Sun Valley Tour de Force as a driver participant for fun and recreation.

I agree to follow the directions of the Sun Valley Tour de Force officials. I understand that I may be excused from participation without refund and asked to leave the grounds if the Sun Valley Tour de Force officials deem my driving unsafe or if my behavior or that of anyone with me is deemed disruptive to the event.

I agree that I willingly accept the risk of driving on the stretch of road that makes up the event course, knowing that it may be dangerous. I understand that I am responsible and accept the liability for the safety of any passengers that I take out on the track in my car during the event. I understand that all forms of motor sports are dangerous and can kill me, and there is a possibility that I and/or my guest(s)/crew could be injured or killed at the event. ## PARTICIPANT DRIVER RULES AND REGULATIONS

All drivers are responsible for knowing this information

**OBJECT:** On the date of the high speed event each participant is given the opportunity to legally run his or her car over the speed limit on the designated event course. Upon completing the Sun Valley Tour de Force Inspection Form in full and submitting the form to the Sun Valley Tour de Force Staff on or before June 15, 2021 and receiving confirmation of a completed registration packet, drivers will be allowed to participate in the event. If your vehicle does not pass event inspection for any reason, you will be disqualified and refunded 50% of your entrant fee.

**SAFETY AND OTHER REQUIREMENTS:** All paperwork must be completed in full and all safety requirements as listed on the Inspection Form must be followed. Please also note that Sun Valley Tour de Force staff may disqualify entrants based on answers in the Medical Statistics form. If you are disqualified on this basis, you will be refunded 50% of your entrant fee.

You must fill out all registration forms including the Medical Statistics sheet, the Entrant Agreement & Releases, the Idaho Transportation Department General Release, and the event Inspection Form and submit it, with payment and photocopies of a valid driver's license, vehicle registration and auto insurance upon registration.

A photocopy of a valid driver's license, vehicle registration and auto insurance must be submitted with registration materials.

All entrants must follow the car safety guidelines as listed on the Sun Valley Tour de Force Inspection form.

All drivers must be at least 21 years of age.

All drivers must wear a helmet and non-synthetic clothing.

Driver must have knowledge of how to open electronic doors of vehicle in the event of an emergency.

There is a fire/rescue crew on sight. However, none of the safety requirements or safety crews can guarantee your safety.   - A padded neck collar and/or a helmet restraint system are recommended
2. \_\_\_\_\_ **SEAT BELTS:** Correctly installed factory seat belts, OEM or better, is the minimum standard. Belts must be in “as new” condition and contain a shoulder and lap strap. Vintage cars must have newer seat belts or harnesses. Lap belts used without any shoulder restraints are not permitted.
3. \_\_\_\_\_ **CLOTHING:** Non-synthetic fabric clothing (cotton, wool, leather etc.) to cover torso, arms (to biceps) and legs is required. Driving gloves are highly recommended. NO open toed shoes, shorts, tank tops or cowboy boots may be worn.
4. \_\_\_\_\_ **TIRES:** Tires must be no more than five years old. If this is not shown on site, driver will be disqualified. All tires must be DOT approved “Z” “W” “Y” rated tires (or better) will be considered the minimum standard. DOT approved race tires are approved.

All tires must have an equal (or greater) Load Carrying Rating and Speed Rating than the original (OEM) manufacturer’s requirement.

Tires may not have unusual or excessive tread wear.

## 2021 SUN VALLEY TOUR DE FORCE RULES

- 1.** Driver registration and inspections will be at the Sun Valley Auto Club on Friday, July 23rd, 2021- from 8:00 a.m. – 3:00 p.m. THIS IS MANDATORY. A safety /logistical meeting will follow with lunch being served at noon.
- 2.** A medical profile is required for all participants and must be submitted with registration forms prior to the event. If you or the Sun Valley Tour de Force event staff feels you are unable to participate due to medical issues, you will not be permitted to participate. If this happens, you will be refunded 50% of your entrant fee.
- 3.** The inspection forms must be completed upon registration, except for the technical inspection, which will take place on July 23rd, 2021 at Sun Valley Auto Club.
- 4.** Please be prepared to identify your fuel type at the event inspection if you are using anything other than pump gas. The Crash Rescue Team MUST be aware of any vehicle that has NOS, nitro, methanol, acetone, or any other oxidizers, additives or exotics aboard. Only commercial gasoline's of commercially available octane's are permissible. No fuel truck will be provided.
- 5.** All drivers must be 21 years of age to participate.
- 6.** All drivers are required to wear a Sun Valley Tour de Force wristband after signing in.
- 7.** All crew and spectators registered on driver registration sheet are required to wear a Sun Valley Tour de Force wristband.
- 8.** Car storage for participant vehicles can be arranged at the Sun Valley Auto Club prior to the event. If you are interested, please contact the Sun Valley Auto Club to arrange for the overnight storage, (208) 578-2323, or other needs, well in advance.
- 9.** Children under the age of 18 must be with an adult at all times. Children are not allowed to operate any type of motorized vehicle at any time.

- 10.** Participants and spectators are not allowed to bring pets.
- 11.** No glass bottles are allowed.
- 12.** Please be respectful of your surroundings – the event takes place in the Sawtooth National Recreational Area. Please pick up after yourself. If you damage the grounds in any way, including an on-track incident or other damage to the roadway, corridor, flora and/or fauna, you will be held liable for damage.
- 13.** NO alcohol is permitted during or before the event. Please refrain from consuming alcohol until the event is concluded.
- 14.** No barbeque pits, cigarettes or flames are permitted on the event site.
- 15.** Please stay hydrated and drink plenty of non-alcoholic and non-carbonated fluids. Bring extra drinks for yourself at the event site. Wear sunscreen.
- 16.** Blaine County Sheriff's Department and Officers will be serving as part of Sun Valley Tour de Force security during the event.
- 17.** There will be a mandatory safety luncheon from 12:00 p.m. – 1:00 p.m. at Sun Valley Auto Club on Friday, July 23rd, 2021.
- 18.** The Sun Valley Tour de Force staff has the sole discretion to postpone or cancel the event due to adverse weather conditions or other natural occurrences.
- 19.** All drivers must follow posted state speed limits throughout the weekend. SVTdF has a special event permit for high speed runs (no speed limit) on Saturday, July 24 between 8am and 3pm, when the road is closed. Any driver who engages in high speed runs outside of the event, throughout the event weekend, will be disqualified.
